Consideration for addition:

 I would like to see something to assure that the access across the district is universal regardless of location. That is not to say the same access for everyone, but comparable technology when compared at the same school level/grade.

Student Centred Learning

Goal #4: "Students successfully transition in their learning environments." What is this goal? The wording is vague and could easily be misconstrued

Strategy #1: "Develop student understanding and ownership of their learning process." This seems like a goal rather than a strategy- it doesn't answer the how expected from a strategy.

Measures- student surveys are mentioned twice (#2 and #4; surveys and survey respectively). Have there been any student surveys? If so, has the data been shared?

#4 "Presentations or reports on how diverse learners are being supported." This does not capture efficacy, the how is not a measure.

Effective Learning Environments

Goal #2: "Understand that reconciliation, equity, diversity, and inclusion in the school community is beneficial."

Is this a goal? Who do we want to understand this? I hope we are already beyond understanding. Valuing?

Strategy #1: "Further the progress of inclusive teaching strategies." This is a goal. There should be a strategy on how to achieve this. Education, training, prioritization of this value in the selection process?

Strategy #2 "Develop a district-wide mental health strategy (Trauma Informed Practice, Social Emotional Learning, and Mental Health Literacy) in collaboration with external organizations."

- This is a goal. There is no strategy here.

In fact the increase in use could point to failures in providing adaptations, accommodations and successful teaching techniques.
