Presentation from FVCDC

Karen – (ED – executive Director), Kim, Erwin (OT – Occupational Therapist) and Robyn (PT – Physical Therapist)

Who are we and how can we help in the community? FVCDC founded in 1982, fully accredited and registered charity, governed by BOD. Community members started the organization out of a church and advocated as there was no one to provide supports for children. Multi disciplinarian organization 150 staff members, Chilliwack, Abbotsford, Mission, Hope and the Cascades. Pride in wrap around services. In addition to a wide variety of support, they also have relationships with many community partners and school district.

Services in Mission: bulk of service are focused more on children prior to school, early intervention, set up for success prior to school. Early intervention of many services to support children in community, SLP, family support key workers, early intervention IDP, SCD. Covid has produced many challenges in providing service but they continue to work.

Referrals can come from anywhere and it is a free service. You don't have to have a diagnosis. Some children are just showing delays, they want to promote that if you have concerns about your child's development they embrace all referrals. If they can't help, they will connect you with more appropriate resources.

DPAC can help by if there are younger siblings or friends, family, please let people know they exist. It is a very strong robust service. They don't like to have wait lists. They focus on what support is most needed at the time if they have multi issues/concerns. They want to meet the family where they are at. When they turn 5, they aid in kindergarten transition. Liaison with school districts that may have accessibility issues.

School age role: Erwin and Robyn, provide services on a p/t basis. They work together to identify the biggest needs. Accessibility issues are important. Seating position/mobility. Equipment issues. Finding funding for equipment. Playground safety. Involved in homes as well. Priority is a consultative role with the school team. Support school team, EA's, normally without covid, there is a pool program. Inclusion is their mandate. Erwin has created a binder for OT, school teams will have access when it is complete. Key worker positions, work with children who either have diagnosis of FASD or DD, referral process. Give support in information, advocacy info, access to community resources, funding, suggestions about what diagnosis look like in school setting. Clinical Counsellors, newer program, referrals come from other staff at FVCDC. Counselling for adults who are connected to centre, short term 12 sessions focusing o their

needs so that they can focus on child needs. Family enrichment program, CYSN referrals, BC and BI's, work on specific goals to help children. 6 month program. Consultants also have experience with self regulation. CALM curriculum and teaching strategy of early identification. Funded by provincial government.

Superintendents report, Angus Wilson:

MASKs, wording that says that masks should and required if people are inside unless seating or drinking. Grade 4-12, K-3 encouraged. Unless you can't wear a mask, they do not require a note, 90% participation. Many emails on both sides of the spectrum. Another note to be sent as really the expectation is for you to wear masks.

Covid variant – no change in conduct, all same protocols in place. 3 notifications last week and expect many more. This Thursday will be an update about vaccinations in schools.

Safer schools – student working groups, 3 schools already working with MCFD, RCMP

Staffing for the schools is being worked on, projected growth, Stave Falls increased, portable may be added to some schools, boundaries around Hatzic, Dewdney, dress code is being sent out to DPAC and other groups for consideration, all flags are half mast for Prince Philip until end of Saturday.

Question from Jacquelyn: heard that some teachers have said they will send kids home if they don't wear a mask, no suspensions for not wearing a mask. School staff will check with home situation.

Question from Cheryl: what kind of training do lunch hour supervisors have? No professional training? Shelley Carter there is not much training. Where is the accountability? Who is responsible? Orientation

at school district office but each school is responsible, the Principal. If there are issues, go to the Principal first. No first aid training.

Parent forum – is there going to be another one or more communication? Angus would like to hear the students talking. Then they will report out to the community. Hatzic is planning a student forum. Priority was to get it out to he schools and have students involved.

MCFD childcare is being switched to ministry of education. Disconnect with staffing levels at school and daycare. Is this going to be a detriment to the quality of care?
